POLICY - EXTRA LESSONS BY STUDENT -TEACHERS

- If a demonstrable need arises in a subject, the teacher may approach the
 principal about engaging suitable past-pupils or other tertiary students to offer
 extra lessons at school in the afternoons under the supervision of the teacher
 and the auspices of the school.
- In a non-obligatory manner, parents will be offered this assistance for their daughters at a reasonable charge payable to the school. The school in turn will in turn pay the student teacher at its rate for such services. No learner will be admitted to class without due payment.

- Parents will be made aware that this is an offer in an attempt to help their daughters who are in need in the subject. The arrangements can be beneficial to all parties because they are convenient and affordable. However, there can in no way be a guarantee of the outcome of the learners' performance in the subject at the end of the term or year.
- A student teacher may be a past pupil known to the teacher/school to have the suitable expertise and qualities, or a tertiary student deemed to have the suitable expertise and qualities.
- Due to the arrival of the novel COVID 19, we have had to extend the
 opportunity from a physical interaction due to constraints placed on us by the
 pandemic- a more appropriate session made available via school approved
 platforms such as Whatsapp and Google Classroom to name a few, are made
 available when needed and if necessary. This also serves as an additional
 form of assistance when deemed necessary by the SMT.
- '...under the supervision of the teacher...' means that there will be regular
 two-way communication between the teacher and student teacher as regards
 progress and content, and that the lessons will be conducted with the subject
 teacher or a stand-in teacher present on the school premises and aware that
 the lesson is taking place.
- The situation will be reviewed by term with a month's notice on either side.
- Recommended rate: September 2018
- Learner pays R35 per hour's lesson
- Student teacher is paid R150 per lesson

(Note: we need 5 learners to cover the cost of a session. 5 x R35)

Policy can be adapted in case of qualified teacher eg. Returned teacher.
